Climate Action Commitment Presentation

John Randolph - Interim Director, Climate Action, Sustainability, & Energy Mary-Ann Ibeziako, AVP for Infrastructure & Sustainability and Chief Sustainability Officer made a presentation to the senate about the Climate Action Commitment. Highlights included:

- Commitment passed last year by Board of Visitors
- Goal for carbon neutrality by 2030
- Reduce single-occupancy vehicle commuting to campus by 20% by 2025

- Social equity and climate justice
- Eliminate fossil fuels and carbon offsets by 2050
- Four pillars
 - Facilities Climate Action
 - Climate and Sustainability Education & Research
 - Sustainable Campus Culture
 - Administration & Governance

BOV Report, June 6-7, 2022

The President informed the Senate of the report that was given to the Board of Visitors on June 6-7. The report was attached to the Senate agenda for the meeting. She noted that:

- All three senate presidents mentioned employee climate in BOV reports
- It is felt that employee climate is a risk of which we all need to be aware
- Looking at solutions like supervisory training, etc.

Job Architecture Project Update - Sandee Cheynet

- Communication documents and materials are available for managers and others to explain the project
- Project will not involve re-organization, nor assess staff positions
- Current pilot project will conclude in late summer (about ¹/₃ of faculty positions)
- If uncovered that pay for a position is significantly lower, there is a plan in place to try and bring that up to equity
